Planning Department Report

Design Review Board: The Design Review Board met on May 17 to consider the following:

- DRB 18-01. The Board continued this to their June 21 hearing.
- FS18-02. The Board approved a replacement freestanding sign for the Cannon Beach Ridge condominiums on 420 Elk Creek Road.

Planning Commission: The Planning Commission met on May 24 to conduct public hearings on the following items:

- V18-03. The Commission conducted a hearing on an off-street parking variance for O'Brien
 Construction at 273 Beaver Street for their offices. The Planning Commission denied the request due to
 concerns about the feasibility of a proposed informal shared parking arrangement.
- V18-04. The Planning Commission conducted a public hearing on a setback reduction request to replace
 an existing dwelling at 707 N Laurel. The request was made by Tolovana Architects on behalf of
 property owners Tom and Brenda Souply. The Planning Commission denied the request because the
 proposal did not meet approval criteria, and because it was feasible to build a fully compliant dwelling
 on the site.
- ZO18-02/CP18-01. The Planning Commission took testimony on proposed updates to the City's Foredune Management Plan. The Chairman closed the hearing, and directed staff to schedule discussion and deliberation on this item for the June 28 Commission meeting.

- The Planning Director and Public Works Director met with Brent Keller, a consulting forester with Mason Bruce & Girard, to discuss their firm's services (4/30).
- The Building Official and Planning Director visited a residential construction site at 608 N Larch and met with the owner to discuss a stalled construction project (5/2.
- The Planning Director and Councilor Ogilvie attended a meeting of the Clatsop County Housing Technical Advisory Committee in Astoria (5/7).
- Michael Duncan of ODOT met with the Planning Director to discuss the City's Transportation System Plan grant application and other highway-related matters (5/9).
- Jay Sennewald of Oregon State Parks & Recreation Department met with the Planning Director to visit several oceanfront sites to discuss shoreline stabilization projects, and to discuss foredune revegetation requirements (5/17).

Public Works Department Report

Water/Wastewater

- A Leak Detection Survey took place the end of April/beginning of May. A total of 23 leaks were identified and totaled 28.25 gallons of water lost per minutes. All leaks will be repaired over the next several weeks.
- Bid's were open for the Ash Street Water Line Project on Thursday, May 17, 2018. The apparent low bidder was Bob McEwan Construction from Seaside, Oregon with a bid amount of 197,448.

Roads/Parks

- In addition to their routine activities, the Parks department installed a purple martin birdhouse, put the
 nets up at the soccer field, helped set-up the Community Festival event, and has been assisting at the
 recycling center.
- The flower baskets were installed May 18th.

- Geese and ducks have been enjoying the nesting platforms at the wastewater treatment plant. Approximately 10 ducklings/goslings have been spotted recently.
- In addition to this year's paving preservation project the City was able to also pave Pacific Street between Surfcrest and Delta, the Public Works Yard, and the Dyke road at the treatment plant.
- Striping throughout Cannon Beach will be refreshed with a completion date of June 30. A new crosswalk will be added at the corner of Beaver and Fir.
- Public Works hosted an Open House on Wednesday, May 23rd at City Hall for staff and the community. City Manager Bruce St. Denis shared words of appreciation for the Public Works team as a whole and their relentless support in caring for our beautiful community rain or shine, day or night.

- Hosted a Black Oyster Catcher training, in partnership with the Audubon Society of Portland and Cape Falcon Marine Reserve on May 4th.
- Sponsored the Marine Reserve Summit in Cannon Beach on May 21st&22nd.
- Melissa attended 15 meetings for various partnering organizations including Friends of Haystack Rock, Oregon Ocean Policy Advisory Committee, Wildlife Center of the North Coast, Friends of Cape Falcon Marine Reserve, 12 Days of Earth Day, and Northwest Aquatic and Marine Educators.

 - Staff have seen quite a bit on the beach the past month: Puffins, murres and other sea birds beginning to conduct nesting activity, such as building nests; a new round of velellas washing in on the beach; a group of 5 goslings crashed down from the top of the rock where apparently the adult Canada Geese had been nesting, four stayed with the parents, one was taken to the WCNC; sights of whimbrels, many different types of shore birds, active peregrine falcons; a sudden influx of visitors as the sun has emerged for the spring.
