WHEREAS, the Council wishes to hold the 12-Days of Earth Day as a City-event; and


WHEREAS, to achieve this goal, the City Council wishes to delegate authority to the Committee to organize, implement and develop policies for the event in line with the Council's mission statement, which will be adopted via a forthcoming resolution.

NOW THEREFORE, THE CITY OF CANNON BEACH COUNCIL ORDAINS AS FOLLOWS:


1. The Cannon Beach City Council amends Chapter 2.36 of the Cannon Beach Municipal Code as described in Exhibit A to this ordinance, which is attached and incorporated by reference.
2. This ordinance is effective 30 days from adoption.



***Chapter 2.36 PARKS AND COMMUNITY SERVICES COMMITTEE***

**2.36.010 Created.**

Chapter 2.36 hereby creates a parks and community services committee herein after referred to as “committee.”

**2.36.020 Powers and duties.**

The powers and duties of the committee shall include the following:

- A. Review and evaluate existing city of Cannon Beach programs, identify needs within the community, and develop plans for and recommend programs to the city council. Such recommendations shall be related to the city’s parks and community services.
- B. Review and evaluate existing city of Cannon Beach programs in recognition of the city’s comprehensive plan for parks, recreation, education, the arts, community and social services and the statewide goals for parks and recreation.
- C. With the cooperation of other public and private agencies, the committee will recommend to the city council strategies and policies that protect environmental, natural and scenic resources; provide for the parks and recreational needs of residents and visitors; promote the arts and certain educational activities and support efforts in the public and private sector to provide needed community and social services within the city of Cannon Beach.
- D. Oversee, evaluate, and review community grant applications, and make recommendation to the city council for community grant awards.
- E. Organize, implement and develop policies for the “12-Days of Earth Day Celebration” in line with the mission statement adopted by City Council by resolution.
- F. Perform other functions as directed by the council.
