It is hard at a meeting to see no names on the zoom list and feel any community spirit accompany the city you represent. I thank the council members, staff and residents who get involved. Every instance of inclusion helps me, and the council work our best for you and the community.

Let me add a bit more on the method of what works best. First we need to clarify that modern email transmission often includes a chain of repeated, forwarded, copied, and pasted posts. Often these are created unaware by the sender and or present as unexpected stacks of repeated chains. Very hard to discern an original draft from a chain of posts. It is understandable to say these messages are 'similar' when sections are exact duplicates. The effort of sorting out chains often weakens the message attempted.

The cure? Post single original message under your name without following a stream or series of links. Take a moment to make the effort, it means more. Personally I'd say this contagion of media comes from a cultural/attitude problem that has crept into the Council's information flow and it needs to be worked out of the culture. Our culture is too loose with social media and it's noncommittal manner of messaging.

Words matter and words inadvertently repeated minimize the power of input from the community. So, if words matter so much, take some extra time and effort to be clear. Show that your thoughts are being laid forth. Copy and paste is less effective than saying, "I agree with 'so-and-so's comment and..."

With that now clear (I hope)...

I do count letters, it is a human thing to do. We do also count the instances people stop us in the post office or on the sidewalk or at an event (masked and distanced), or call for a short chat. Yes that is not an official public document but it is just as important. Moments made in person are hard to quantify except to the person [ Councilor ] who listens. I listen, we listen. I believe staff even listens, though their job is different than ours.

I also understand the concept to compare who has what in reference to a topic, another very human thing to do. Also an imperfect example of the challenge of my position. I get it. Many directions in any argument lead to comparisons of points of view. Part of the challenge the elected policy maker must endure is understanding the elements of an argument in order to filter each point toward pertinent consideration.

Thank you for listening to my rant on communication. **Mayor Sam** 

A second letter from Mayor Sam Steidel

Why are we discussing residential homes of late, specifically, size?

Well for one it has become quite evident that our old ordinances do not meet the challenges we knew were coming.

I ask interested parties to read the City Comprehensive Plan, specifically the Vision. It is obvious past policy makers had size, character and natural environment in their sights. They envisioned how the future would become what we are seeing today. Huge influx of visitors, tourism related demands, and new residents romanticizing quaint charm but bringing upscale out of context attitudes.

We now can envision a future that both goes far beyond what our predecessors were able see and the repercussions that come with those changes. There is a lot to unpack here, the very reason we are initiating a Code review process. Which I would like every one to understand will be a long and involved process on the part of City and Community. I repeat Community, [ which means you all ] along with the Council, Planning Commission and Design review and other appointed boards.

Back to the topic, the idea that we needed to fast track residential size. No more fast track, but, home size may be the first step of the next part.

I believe Livable square footage of a home is a personal choice. Your home your space. That said, if you come to a quaint small town that imparts a desire to retain it's quaint small charm, be aware, personal space is something that is regulated. Or so our Comprehensive Plan set forth in the hope our Ordinances would support and defend, and should.

To me the impact of a built structure on the character of the community is the visible size of the structure and in some regards style in relation to the apparent mass. A perception that at one time was the community wide choice. Read the Vision statement of the Comprehensive Plan in light of those who wrote it, not in today's cultural view of what is an average acceptable home size today. That is the Village character I see our ordinances must support.

Obviously there were large homes in past times. Easily enough for prior residents of the 70s and 80s to envision how the community could be covered with McMansions, then. Easy to see how that was a fear.

The term McMansion was as much a term of sentiment then as it is now. Only now we can see the ever expanding evidence. As well we see evidence how the ordinances in place do not suit their intent. We are now facing the challenge that we do not have the proper tools to address how to maintain the affectation of 'Village Character' so desired and cherished in the Comp Plan. The guiding principle of the elected policy maker.

The designers of the Comp plan did not foresee that second homes would so readily become commerce and rise to be our primary housing type. Nor could they have imagined property values climbing so fast or so dramatically. It is our time now to bridge between past desires of what 'Village character' means and the modern insult we face today, the McMansion.

We must not whine about errors that slipped past the gate keeping ordinances or about perceived harsh efforts to bring on overt denial of personal desires. Time now is for us to recognize the balance so sought after in the Vision. Key word, balance. Not re-set or requantify the balance, keep it. Hold it dear as a principal guiding desire of what this community desired and what modern life brings.

What is the question we need to answer? An excellent point was made recently that it is the question you ask which guides how we approach our discussions. Such as...

"Do you think we should have more 'huge' houses that are out of character?"

"Do you think we should require houses to be so small that they can't reasonably be used by families?"

I borrowed those two, thank you to who offered them. Other potential questions...

"Does a large structure fit in the definition of village character? In the neighborhood id joins?"

"Do small cabins removed and replaced by maxed out building envelopes reflect neighborly design?"

"Does the 'livability' choice of the private citizen superseded the general community preference as considered in the City Vision?"

"Do my property rights end at the property line?"

I could ask a jillion questions that lead to a jillion answers.

I find it amusing we have run smack into Spock's logic dilemma ... "The Needs Of The Many Outweigh The Needs Of The Few. Or The One." Or do the desires for 'living space square footage' outweigh the historic desires of the community on which one choses to live in? Or the goal to maintain the Village Character appeal of that community.

My take though is that Village character is a hold over aesthetic from a not too distant past. It is what folks remember from when they were young, coming to the beach on a summer vacation. It is a natural sensibility, to reminisce and hold close the novelties of past memories, imperfect as they may be.

The city Comprehensive Plan intones 'Villager character' as the ideal. That said, and I repeat intentionally, the current ordinances do not make keeping hold of this ideal an easy task for city or home owner. What with modern sensibilities being at odds with an older Village character preference. One that was built of cozy beach cabins from an era that is memorialized by sentiment. Though also of a time when families did live in smaller homes, comfortably.

I made mention of Garages in a recent meeting. "Two car garages are ugly". I did not say they need to stop. Simply a commentary of my opinion. As to garages in general I take exception to the expressed absolute cultural requirement of them. As example, take a walk up West 1st Street. Note the design handling of the homes. Garage portals facing the most observable face of the homes along the short walk are few. There are garages though. Some hidden behind, some as detached smaller structures, some screened, some obvious and some without.

Variety and attention to design are all the better components of placing a garage in a neighborhood. Attention is dependent on the neighborhood aesthetic not as much the individual facade.

These are Planning and Architectural 'terms of art' that the average person in town doesn't usually try and understand until confronted by it. It helps in discussions toward with the same definitions when terms are thrown out.



**On Saturday, Jan 15th, we experienced an actual Tsunami event**, which brought up concerns of public notification systems, from the COWS (speaker) system and beyond.

**Emergency Manager Rick Hudson wants to express how important it is to stay connected with factual and real time information that you can use during an emergency**. Rick suggests signing up for a trifecta of locally-based notification services (all are free). Of the three, Rick recommends Nixle as the most effective. Details and how to sign up to each below.

#### 1. <u>Nixle</u>

Nixle is controlled locally by Cannon Beach Police. It covers our local zip codes and is very easy to register for. The CBPD uses this service sparingly and only when they need to get out an emergent message to Cannon Beach.

#### 2. <u>Clatsop Alerts</u>

Clatsop Alerts is a county wide notification system administered by the Clatsop County Emergency Management team. Notifications include other issues, such as COVID vaccination clinics, road closures and more. This service is also sponsored by the State of Oregon and used in statewide emergencies for notifications, evacuations and larger scale events.

#### NOTICE OF VACANCIES CITY COMMISSIONS, BOARDS & COMMITTEES

The City of Cannon Beach is seeking applications for the following vacancies:

**TOURISM & ARTS COMMISSION**: ONE (1) vacancy to fill four-year term immediately. The seven-member Tourism and Arts Commission develops grant guidelines and procedures and distributes and accounts for the monies in the "Tourism and Arts Fund" which are to be used by local non-profit groups to promote tourism and the arts in Cannon Beach. Each member shall have experience in one or more of the following areas: public relations, marketing, advertising, tourism, lodging, promotions, events promotion, art and/or publicity. The Tourism and Arts Commission holds its meetings as needed. Note: Tourism and Arts Commission applicants are not required to reside in Cannon Beach and are eligible if he or she has worked, at least part-time, within the City of Cannon Beach for at least one year, immediately preceding appointment.

**BUDGET COMMITTEE**: TWO (2) vacancies to fill three-year terms, beginning immediately and a three-year term beginning February 1st. The Budget Committee fulfills an important need for citizen involvement in the City's budget process. The committee is involved in preparing the budget, and in helping to bring the budget to public awareness before it is adopted by Council prior to the end of the fiscal year (June 30). There are five members on the Budget Committee, and meeting times vary. Note: Budget Committee members must be a qualified voter of the district and must provide copy of voter registration card with application.

To be eligible to serve on a City committee, applicants must have resided within the city or its urban growth boundary during the one year immediately preceding appointment; or at the time of appointment, shall have owned real property located within the city or its urban growth boundary for at least one year immediately preceding appointment. (See 'Note' re: TAC and Budget).

#### What is the Short-Term Rental Task Force?

The City Council created the ad hoc Short-Term Rental Task Force in 2019. The STR Task Force incorporates a broad spectrum of Cannon Beach citizens, from industry professionals to homeowners and area stakeholders. (EVEN THOUGH THEY CAN APPEAR DOCILE)

### HERE ARE A FEW SUGGESTIONS TO ENJOY THEM SAFELY:

- Watch from a safe distance of at least 100 feet.
- Be aware of your surroundings to avoid surprising a herd, and never walk into the middle of a herd.
- Be careful at night and carry a flashlight.
- Keep pets on a leash at all times Elk see dogs as a predator and potential threat.
- Elk are most active at dawn and dusk along roadways and migration routes. Drive slowly.
- September/October (breeding season) and May/June (calving season) are times when Elk can become more aggressive.
- Please do not feed Elk. It can be harmful to them and it is illegal to feed any wildlife in Cannon Beach.



#### **CITY HALL CLOSED TO VISITORS EXCEPT BY APPOINTMENT**

Effective **August 27, 2021**, the following policies will be in place per <u>Administrative Order 21-02</u>:

- All City operations will continue with the exception that City Hall will be closed to visitors inside the building. All in-person transactions will take place through the walk-up window installed next to the ballot drop box.
  - The service window will be open daily from 8:00 5:00 pm
  - If you need to meet with a staff member, please schedule an appointment with that staff member
    - A predetermined time and location will be set and staff will meet you there, i.e. Council Chambers door at 2pm
  - For non-monetary transactions with the Community Development Department, the drop off/pick up box is still available outside their office
- There will be no audience members for City Council, Commissions, Boards and Committees meeting.
  - All public comment, participation and attendance will be through Zoom only

  - Members of Council, Commissions, Boards and Committees may attend in person or via Zoom
