



A FEW **HOLIDAY** REMINDERS FROM THE CANNON BEACH POLICE DEPARTMENT

- Celebrate RESPONSIBLY and please don't drink and drive.
- Lock your vehicles and keep valuables well hidden (a purse, wallet, or presents in plain sight is an easy opportunity).
- Keep your doors and windows locked and leave a lamp or two on a timer while you're away.
- If you're going to be gone for a few days, let us know so we can conduct extra patrols and keep an eye on your house.
- Take a proactive approach, making sure your neighbors are doing well and have what they need to make it through the winter.
- **Night safety, please keep yourselves and your pets away from the Elk, dress visibly and have a flashlight when it is dark, know your surroundings.**

ALL FIREWORKS ARE PROHIBITED WITHIN CANNON BEACH CITY LIMITS. 9.16.030 Violation— Penalty levels

In addition to other penalties provided by law, a violation of this chapter is punishable by a fine not to exceed five thousand dollars depending on the type of the firework and the fire threat in the city at the time of the violation.

A. Level One Violation. Discharging or causing to be discharged any novelties or trick noisemaker, handheld sparkling device, or similar firework is punishable by a fine not to exceed one hundred dollars unless enhanced.

B. Level Two Violation. Discharging or causing to be discharged any ground device, audible ground device, or any similar firework is punishable by a fine not to exceed one thousand dollars unless enhanced.

C. Level Three Violation. Discharging or causing to be discharged any aerial device or similar firework is punishable by a fine not to exceed five thousand dollars.

D. Discharging or causing to be discharged any combination item is punishable by a fine not to exceed the maximum fine of the most severe grade of firework in the combination item, unless the fine is enhanced.

E. A violation of this chapter where the size, pyrotechnic composition, or explosive composition of the firework exceeds the maximum size or amount described in the definition enhances the fine one level, not to exceed five thousand dollars.

F. A violation of this chapter during fire season as declared by the Oregon Department of Forestry and/or Clatsop County Fire Defense Board, during a fire weather warning as declared by the National Weather Service, or during a high fire threat as declared by another agency with special fire authority or knowledge, enhances the fine one level, not to exceed five thousand dollars.

G. A violation may be enhanced no more than two levels.

H. Each firework discharge or causing to be discharged is a separate violation. (Ord. 21-06 § 1; Ord. 20-18 § 1)

NOTICE OF VACANCIES CITY COMMISSIONS, BOARDS & COMMITTEES

The City of Cannon Beach is seeking applications for the following vacancies:

TOURISM & ARTS COMMISSION: ONE (1) vacancy to fill four-year term immediately. The seven-member Tourism and Arts Commission develops grant guidelines and procedures and distributes and accounts for the monies in the "Tourism and Arts Fund" which are to be used by local non-profit groups to promote tourism and the arts in Cannon Beach. Each member shall have experience in one or more of the following areas: public relations, marketing, advertising, tourism, lodging, promotions, events promotion, art and/or publicity. The Tourism and Arts Commission holds its meetings as needed. **Note:** Tourism and Arts Commission applicants are not required to reside in Cannon Beach and are eligible if he or she has worked, at least part-time, within the City of Cannon Beach for at least one year, immediately preceding appointment.

DESIGN REVIEW BOARD: ONE (1) vacancy to fill four-year term beginning 1/1/22. The Design Review Board reviews development proposals that are subject to the design review provisions of the City's zoning ordinance. There are five members on the Design Review Board. The Design Review Board holds its regular meetings on the third Thursday of each month at 6:00 p.m. and may also schedule work sessions as needed.

BUDGET COMMITTEE: TWO (2) vacancies to fill three-year terms, one beginning immediately and one beginning 1/1/22. The Budget Committee fulfills an important need for citizen involvement in the City's budget process. The committee is involved in preparing the budget, and in helping to bring the budget to public awareness before it is adopted by Council prior to the end of the fiscal year (June 30). There are five members on the Budget Committee, and meeting times vary. **Note:** Budget Committee members must be a qualified voter of the district and must provide copy of voter registration card with application.

PARKS & COMMUNITY SERVICES: ONE (1) vacancy to fill a four-year term beginning 1/1/22. The Parks & Community Services Committee recommends strategies and policies that protect natural and scenic resources, provides for the recreational needs of residents and visitors, promotes certain educational and cultural activities, and supports efforts in the public and private sector to provide needed social services. The Parks & Community Services Committee holds its regular meeting on the third Thursday of each month at 9:00 a.m. and may schedule work sessions as needed.

To be eligible to serve on a City committee, applicants must have resided within the city or its urban growth boundary during the one year immediately preceding appointment; or at the time of appointment, shall have owned real property located within the city or its urban growth boundary for at least one year immediately preceding appointment. (See 'Note' re: TAC and Budget).

CITY HALL CLOSED TO VISITORS EXCEPT BY APPOINTMENT

Effective **August 27, 2021**, the following policies will be in place per Administrative Order 21-02:

- All City operations will continue with the exception that City Hall will be closed to visitors inside the building. All in-person transactions will take place through the walk-up window installed next to the ballot drop box.
 - The service window will be open daily from 8:00 – 5:00 pm
 - If you need to meet with a staff member, please schedule an appointment with that staff member
 - A predetermined time and location will be set and staff will meet you there, i.e. Council Chambers door at 2pm
 - For non-monetary transactions with the Community Development Department, the drop off/pick up box is still available outside their office
- There will be no audience members for City Council, Commissions, Boards and Committees meeting.
 - All public comment, participation and attendance will be through Zoom only

 - Members of Council, Commissions, Boards and Committees may attend in person or via Zoom
