

CITY POLICY
FOR COMMENTING ON OREGON PARKS DEPARTMENT
MISCELLANEOUS USE PERMIT
FOR NONTRADITIONAL PARK ACTIVITIES

The following standards were adopted by the City Council at its November 6, 2001 meeting. The standards contained in the policy are to be used by the staff in providing comments to the Oregon Parks Department on "Miscellaneous Use Permit for Nontraditional Park Activities" applications

A. Large Group Gatherings and Events - Weddings/Company Picnics

1. Vehicles are permitted on the beach only to deliver and remove structures and equipment related to the event.
2. No amplified music is permitted.
3. No artificial lighting is permitted.
4. No portable generators are permitted.
5. No portable toilets are permitted. Portable toilets may be allowed at an approved upland location.
6. The gathering or event will not be located within or immediately adjacent to the Haystack Rock Marine Gardens. The Haystack Rock Marine Gardens exclusion area is defined on the map titled "Haystack Rock Marine Garden Exclusion Area."
7. The gathering or event will not be located within 100 feet of a public access to the beach.
8. The location of the event will not have the effect of entirely restricting the public's north/south movement along the beach.
9. A gathering or event associated with a commercial use such as a motel will occur only on the portion of the beach immediately west of a commercial or motel zone.
10. The gathering or event will not be located within 1,000 feet of another event occurring that day.
11. The gathering or event will conclude not later than 10:00 p.m.

B. Commercial Filming

1. Vehicles are permitted on the beach only to deliver and remove structures and equipment associated with filming.
2. At no time will any activity, including the use of water craft, associated with the filming occur within or immediately adjacent to the Haystack Rock Marine Gardens. The Haystack Rock Marine Gardens exclusion area is defined on the map titled "Haystack Rock Marine Garden Exclusion Area."
3. No aircraft of any type may be used in association with the filming.
4. The filming will not have the effect of entirely restricting the public's north/south

movement along the beach.

5. An off-duty Cannon Beach Police Officer, or approved security personnel will be employed to provide project security and public information.

C. Larger Organized Beach Events

The following standards are applicable to future events. The standards are not applicable to the the Dog Show, the Kite Festival and the Sandcastle Contest. However, these events must continue to be operated in the manner in which they were operated prior to the adoption of the city's standards. Any significant change in the operation of the event must comply with the appropriate standard for larger organized beach events.

1. Vehicles are permitted on the beach only to deliver and remove structures and equipment related to the event.
2. No outdoor merchandising is permitted.
3. No amplified music, or voice amplification is permitted.
4. No artificial lighting is permitted.
5. No portable toilets are permitted. The city may require the placement of portable toilets at an approved off-beach location.
6. The gathering or event will not be located within or immediately adjacent to the Haystack Rock Marine Gardens. The Haystack Rock Marine Gardens exclusion area is defined on the map titled "Haystack Rock Marine Garden Exclusion Area."
7. The event will not be located within 100 feet of a public access to the beach.
8. The event will not have the effect of entirely restricting the public's north/south movement along the beach.
9. An event sponsored by a commercial use such as a motel will occur only on the portion of the beach immediately west of a commercial or motel zone.
10. The gathering or event will conclude not later than 6 p.m.
