VACCINE INFORMATION

Clatsop County and its local partners are striving to ensure that local residents can receive the COVID-19 vaccine in as timely and convenient a manner as possible.

Vaccines are being administered according to a multi-phase plan from the Oregon Health Authority.

GROUPS CURRENTLY ELIGIBLE FOR VACCINATIONS: All individuals ages 12 and over

PLEASE NOTE: Currently the Pfizer vaccine is the only one approved for individuals under 18 and will be used for all individuals 12 to 17 years old who want to be vaccinated. Immediate family members of those 12 to 17 years old can also receive the Pfizer vaccine at the same events.

Other individuals age 18 and over who wish to be vaccinated will receive the Moderna vaccine.

NOTICE OF VACANCIES CITY COMMISSIONS, BOARDS & COMMITTEES

The City of Cannon Beach is seeking applications for the following vacancy:

TOURISM & ARTS COMMISSION: ONE (1) vacancy to a fill four-year term immediately. The seven-member Tourism and Arts Commission develops grant guidelines and procedures and distributes and accounts for the monies in the "Tourism and Arts Fund" which are to be used by local non-profit groups to promote tourism and the arts in Cannon Beach. Each member shall have experience in one or more of the following areas: public relations, marketing, advertising, tourism, lodging, promotions, events promotion, art and/or publicity. The Tourism and Arts Commission holds its meetings as needed.

Note: Tourism and Arts Commission applicants are not required to reside in Cannon Beach and are eligible if he or she has worked, at least part-time, within the City of Cannon Beach for at least one year, immediately preceding appointment.

To be eligible to serve on a City committee, applicants must have resided within the city or its urban growth boundary during the one year immediately preceding appointment; or at the time of appointment, shall have owned real property located within the city or its urban growth boundary for at least one year immediately preceding appointment. (See '**Note**' re: TAC).

EMERGENCY MANAGEMENT VOLUNTEER TEAMS RECOGNITION



The City of Cannon Beach Emergency Management volunteer teams were very active during the 2020-2021 COVID-19 pandemic. Without their dedication to the community, we would not have the type of caring and skilled response we currently enjoy. They are the best any of us could hope for, and more than we deserve. Please join us in extending a big **"Thank You"** to our dedicated volunteer response corps!

Community Emergency Response Team (CERT)

The CERT team was very instrumental in keeping our community together and informed. They performed many different functions and assisted the Medical Reserve Corps (MRC) when they began the monumental task of vaccinating. The CERT supported the county at call centers, helped the MRC at the vaccination locations and never once turned down an opportunity to assist the community.



- In **2020** the CERT provided 442 service hours to the community excluding training for a volunteer value of \$12,474.
- In **2021** the CERT provided 108 service hours to the community for a volunteer value of \$3,048.
- In total, the CERT provided **550 service hours** during the COVID-19 pandemic (March 2020 - June 2021) for a **volunteer value of \$15,521**.



This team was working in small groups and social distancing.

Areas of influence:

- Residential survey of at-risk citizens, March 2020
- Monthly mask delivery for citizens, June 2020 – March 2021 (over 14,000 masks delivered)

- CERT beach clean-up with SOLVE, July 2020 – October 2020
- Community Preparedness Fair, September 2020
- City survival cache site opening, October 2020 & April 2021
- Assisted Clatsop County at call centers and vaccination sites, March 2021 – May 2021
- Vaccine sign up community members assistance, April 2021



Medical Reserve Corps (MRC)

The MRC is comprised of members of the CERT and the Disaster Animal Response Team (DART). The mission of the MRC is to provide medical skills and training for the community and other teams.



The MRC team is also involved with the CERT discipline. They supported the CERT activities in 2020. In 2021 the MRC was called on to support the Clatsop County Public Health Department and community. The MRC team initially assisted the Clatsop County 211 public health center, then moved into the vaccine clinics in Astoria and Seaside.

The county is currently planning more pop up clinics in Cannon Beach and the MRC is instrumental in making sure that Clatsop County has enough skilled volunteers to answer the call. There were also members of the community not associated with the MRC but did volunteer their medical skills at the vaccine clinics.

- In **2021** (January - June) the MRC team provided **1223 service hours** to Clatsop County and the community for a **volunteer value of \$53,194**.

- Call center specialist at the 211 center, February – June 2021
- Vaccine site workers providing skilled vaccine distribution & medical monitoring, February - June 2021



Red Cross

We have several of our CERT, MRC & DART members who are also members of the Red Cross. Their level of dedication to the community is without question. Prior to the COVID-19 pandemic, Cannon Beach did not have much interest in donating blood to the Red Cross. Events had not been scheduled for some time. With the efforts of our Cannon Beach Red Cross volunteers, they were able to convince the Red Cross senior staff that Cannon Beach is a dedicated group, and we want to donate to others for life.





The Chamber of Commerce Hall building was secured as a dedicated site for blood donations. All scheduled spots were filled and we even had to turn away donation volunteers.

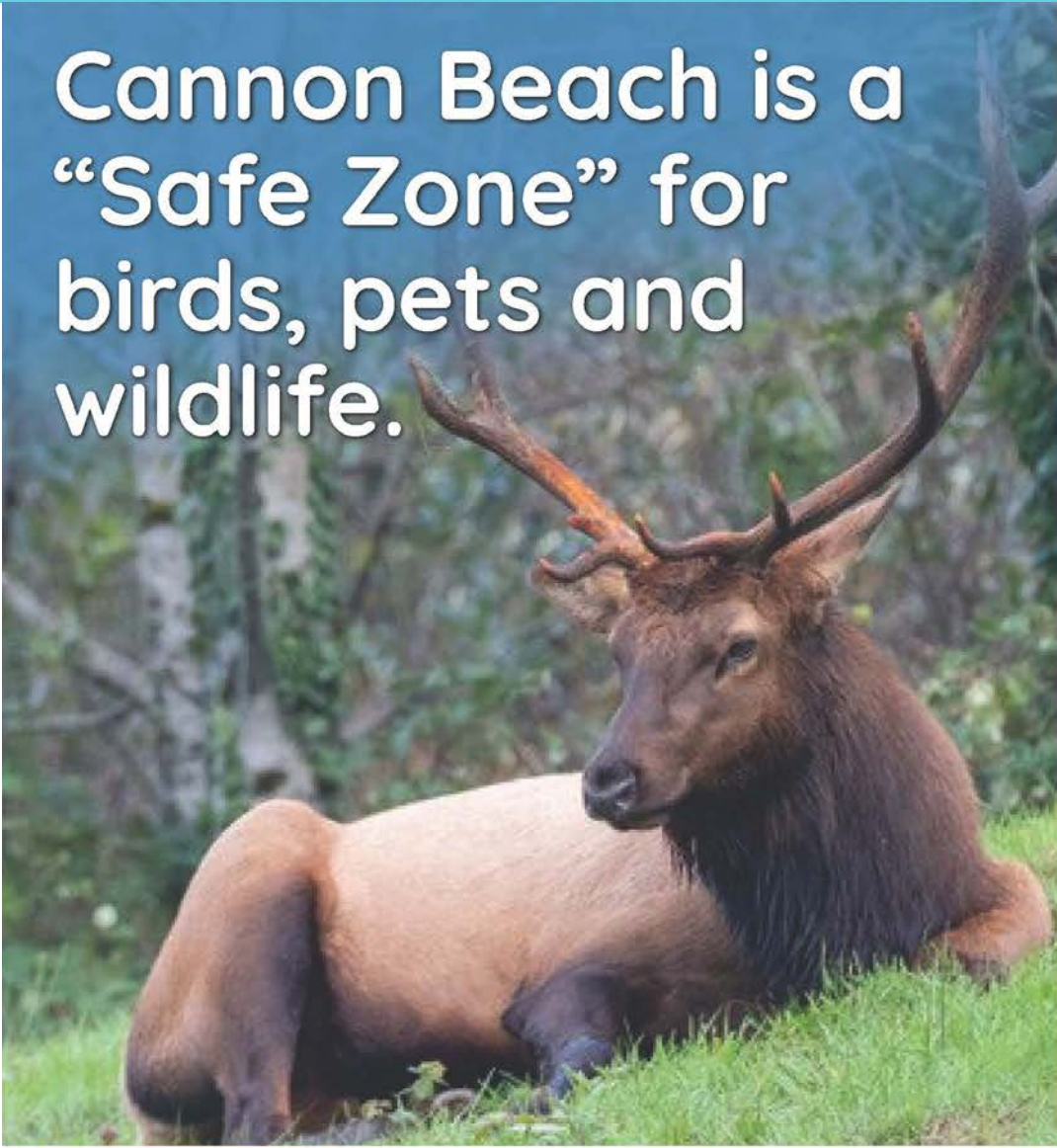
