

**NOTICE OF PUBLIC HEARING
CANNON BEACH DESIGN REVIEW BOARD**

The Cannon Beach Design Review Board will hold public hearing on **Thursday, January 19, 2023 at 6:00 p.m.** at Cannon Beach City Hall, 163 East Gower Street, Cannon Beach, regarding the following:

DRB 23-01, Karen La Bonte, applicant, on behalf of City of Cannon Beach, for the remodel of the midtown restroom. The property is owned by City of Cannon Beach and is located in the Coolidge Right-of-Way 1216 S Hemlock & 1188 S Hemlock (Tax Lots 10400 & 10700, Map 51030AD) in a Limited Commercial (C1) zone. The application will be reviewed against the criteria of Municipal Code, Chapter 17.44.080-17.44.100, Design Review Criteria.

All interested parties are invited to attend the hearing and express their views. Statements will be accepted in writing or orally at the hearing. Failure to raise an issue at the public hearing, in person or by letter, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue precludes appeal to the Land Use Board of Appeals based on that issue.

Written testimony received one week prior to the hearing will be included in the Design Review Board's meeting materials and allow adequate time for review. Staff reports are available for inspection at no cost or may be obtained at a reasonable cost seven days prior to the hearing.
