At the September 13th Code Rewrite Joint Work Session, the following issues were highlighted for greater discussion at a follow up session: 1) Code Rewrite Project update and 2) Engaging the public in the Code Rewrite project. The agenda for October 16th will address these topics in detail, as follows.
